Challenge Definition

We have partnered with key business stakeholders to define two business problems that support our Sustainability agenda and we believe can deliver real benefits to our customers.

How can you get involved?

Our challenges are now live and we are looking for new and innovative ideas to help solve these challenges. If you think you can help us, we want to hear from you - applications are now open to join our Discovery phase.

The deadline for applications is Friday 4 February 2022.

Discovery Phase (3 weeks)

Once we reach our closing date for applications, we will begin our Discovery Phase. During this time you will have time to meet with our leaders and understand more about the research that has been conducted to support our challenges. From there you will have time to refine your proposal before going through to our shortlisting stage.

Our information sessions will take place early February 2022.



Design Phase (4 weeks)

During the Design Phase a number of solutions will be taken forward to start working in partnership with our industry experts.

You will have dedicated time where you can get input into your ideas ahead of your initial pitch.

The pitches will be to leaders within the business who are working in these areas.

Panel Event

Our final part of our Innovation Phoenix initiative is our Panel Event. This is where our final pitches will be made to our Business Sponsors.

Our Business Sponsors will then select the solution that best fits our challenges and our business needs.

Next Steps

Following the panel event we will work with the companies /individuals that have been selected on a proof of concept.

By sharing this with customers and colleagues we can further understand the value of the solution and how to deploy it to our customers.
